All the above Three trustees shall constitute the Board of Trustees and Mr. A. Aloysius shall be the Managing Trustee of the trust. The Trustees with their mutual consent can increase or decrease the number of trustees of the board in future. (The number of trustees at any point of time shall be subject to a minimum of 3 and shall not exceed 7 in number)

**4. The Objects of the trust shall be as follows:-**

**Main Objects:**

1. To build, lease, own, run and maintain Nursery, Primary, High School and Higher Secondary Schools with the approval and affiliation of state board, Matriculation, CBSC.
2. To build, lease, own, run and maintain Arts & Science Colleges, business schools, engineering colleges, teacher training institutes, nursing schools, medical colleges etc., with the approval/affiliation of universities and other educational institutions like Vocational training Institutes, Community colleges, fashion designing, hotel management and catering technology institutes, polytechnics.
3. To build, lease, own, run and maintain book banks, entrance examination coaching centers, reference rooms, study classes, hostels.
4. To seek and get affiliation to universities and open universities.
5. To provide educational support to needy and poor children.
6. To work for the elimination of child labor and to provide education and life skills trainings to children.
7. To undertake the implementation of literacy through non-formal education programmes and projects for the purpose of achieving 100% literacy.

8. To build, lease, own, run and maintain vocational training centers in computers, tailoring, Travel, Tourism, Hospitality, electrical, electronics, fashion designing, handicrafts, industrial, and employment awareness, etc., to support youth for sustainable livelihoods.
9. To undertake educational, legal, environmental, agricultural awareness activities and to strengthen human resource development.
10. To undertake environmental education programmes through Environment Resource Centre for children, youth, women, NGOs etc., and to develop nurseries and tree plantation programme in order to preserve natural resources.

**Ancillary Objects:**

1. To demonstrate the models of bio-diversity/ecological conservation and renewable energy models for creating awareness amongst the general public.
2. To promote sustainable agriculture, natural resource management and to conduct research on indigenous methods in agriculture and rural development including rural Bio-technology processing, Bio-diversity conservation, energy conservation and renewable energy.
3. To involve in alternative nature / Eco-farming for sustainable development.
4. To build, lease, own, run and maintain and help welfare institutions for women and children, orphanages, homes for handicapped, mentally challenged & the elderly etc.,
5. To organize camps, training programmes, competitions, seminars, conferences, symposiums, exhibitions, tours, tournaments, games etc. in order to develop creativity, personality and scientific outlook among youths.

6. To undertake and execute developmental Projects for the benefit of the backward, downtrodden, particularly Women & Children, farmers, tribal and other working people in rural and urban areas.
7. The above objects are independent of each other and the trustees may from time to time apply the funds of the trust in carrying out all or any one of the objects of the trust.

**5. Membership:**

The trustees may be an individual or a person representing a corporate body.

**6. Tenure:**

(a) **Mr. A. Aloysius** shall be the Founder/Managing Trustee and shall hold office for life or until he resigns.

(b) The other trustees shall hold office for three years or until they resign or cease to hold office as trustees or terminated. Trustees are eligible to be re-appointed at the end of their term.

7. In the event of any vacancy being caused for whatever reason in the office of the Managing Trustee, a new trustee shall first be chosen to fill up the vacancy caused by the exit of the Managing Trustee and thereafter the Managing Trustee will be appointed by election within a month. The trustee so appointed shall also participate in the election of Managing Trustee.

8. (a) In the event of having only two trustees in the board at any time the appointment of other trustees will be made by consensus. If there is any difference of opinion in the appointment of other trustees, between subsisting two trustees, the Managing Trustee will have a "Casting Vote" in addition to the vote as trustee. In the absence of the Managing Trustee, the eldest of the trustee in age will act as Managing Trustee with a casting vote for the time.

(b) No person shall hold or continue to hold office or be appointed as a trustee and the trustee's office shall be vacated ipso facto.

- i. If he or she is found to be or become a person of unsound mind
- ii. If he or she is convicted of an offence involving moral turpitude
- iii. If he or she is adjudged as an insolvent
- iv. If he or she is or become deaf-mute
- v. If he or she is in the opinion of the majority of his/her co-trustees, is found to be negligent or guilty of dereliction of duties.
- vi. If he or she fails to attend the board meeting continuously for 3 meetings
- vii. If he or she is otherwise disqualified to act according to law to which he or she is subject to for the time being in force.

9. Whenever any person is appointed as a trustee of the trust hereby disclaims or any such trustee either original or substituted dies or is for a continuous period of fifteen months absent without leave of the board from the Indian union or leaves the Indian union for the purpose of residing abroad or desires to be discharged from the trust or refuses or becomes in the opinion of majority of his or her co-trustees unfit or personally incapable to act in the trust or is disqualified in terms of the provisions of clause 8 supra, a new trustee shall be appointed in his place by the Board.

10. The powers vested on the board of trustees on the amendments of trust deed would not extend to altering the basic character / object of the trust and further, no such amendments which may prove to be repugnant to the provisions of section 2 (15), 11, 12 & 13 and 80G of the Income Tax Act.

11. The administration, direction, management of several institution and establishment in terms of the trust hereby created shall be subject to the supervision, control and direction of the Managing Trustee.

12. The funds of the trust derived from the sum add investments of the said funds as set out infra.
- a. The funds of the trust shall be invested in accordance with the provisions of section 11 (5) read with section 13 (1)(d) of the Income Tax Act.
  - b. The trustees may open current or savings bank or fixed deposits with any banks or Governments and in the modes and forms specified under the provisions of the Income Tax Act and Rules made there under as approved by board by means of a resolution recorded at the meeting of the board. The bank accounts shall be operated by the Managing Trustee and Financial Trustee jointly.
13. The board shall have power to accept contributions, money or property by way of addition to the trust funds generally or for any one or more of the specified objects of the trust and in either case such contributions shall be dealt with either as capital or as income according to the directions of the donors at the time of the gift.
14. If in the opinion of the board any property belonging to the trust deteriorating in value or is not yielding reasonable income or that its sale or conversions in the property of any other or exchange the same property for any other kind or to sell the property and invest the proceeds in the manner herein provided and the Managing Trustee is empowered to do all the above acts on behalf of the trust.
15. The board shall have power to levy fees or charges from the students, apprentices or other beneficiaries from the institutions and establishments maintained and conducted by the trust and also to give exemption from payment of any fees or charges that may be fixed by the board from time to time.

16. The Managing Trustee has powers and authority to execute such documents as are necessary in favor of Governments for and on behalf of the trustee in respect of mortgages or charges to be created on all or any of the properties of the trust as the board may from time to time decide.
17. The board shall have power to call in and convert into cash the trust properties and realize any or all the securities and investments and reinvest them in such manner as is authorized herein and shall have power to borrow from time to time from banks individuals, or others, thereby giving security or otherwise such sum as they may deem necessary for the purpose of the trust and to execute such documents as may be required on that behalf either with or without interest.
18. The grants-in-aid shall be strictly applied for the purpose for which they may be received from Government and other agencies and the board may advise the Managing Trustee to apply the grants for the purposes for which they may be applied for and received.
19. Whenever for the administration of the trust hereby created or for the establishment, development and conduct of the several institution maintained hereunder. Grants-in-aid from Government are applied for the objects and it becomes necessary for the due performance of the conditions of such mortgages or charges or all or any of the trust properties or facilities to facilitate the obtaining of such grants for purchase of lands and for administrations and conduct and maintenance of such institutions.
20. Except as otherwise provided herein, none of the trustee for the time being of the trust shall have power jointly or severally to mortgage or charge on any of the trust properties.

21. In the professed execution of the trust and powers hereto, no trustee shall be liable for any loss to the properties arising by reason of any investments made in good faith except willful or deliberate fraud or wrong doing on the part of the trustees who may be subject to be made liable.
22. The Managing Trustee shall maintain correct accounts regularly and every year, the accounts shall be closed by 31<sup>st</sup> March and the same shall be audited by a qualified Chartered Accountant. The accounting year of the trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March of the next year.
23. The Managing Trustee shall have power to purchase from time to time such materials and things as may be necessary for the said educational institutions, hostels, reading rooms, medical institutions, development projects and other establishments without profit motive.
24. It is hereby declared that the objects / activities of the trust shall be carried out only in India.
25. No act of the Managing Trustee in exercise of the powers hereby specifically conferred on him / her shall be called to questions or interfered with by the board except on the grounds of manifest impropriety on the ground that it is gross breach and neglect of duty on the part of the managing Trustee.
26. The Managing Trustee if and where he / she desires, may delegate for a temporary period, his/her authority in respect of the administration of institutions and development projects to one of the co-trustees.
27. The Managing Trustee shall have the custody and control of all the documents of the title to the properties of the trust and all other documents, accounts and other papers, relating to the trust and be open to inspection by any trustee on reasonable notice during the office hours of the trust office.

28. It is hereby declared that the benefits of the trust are open to all, irrespective of caste, religion, sex, colour, etc..
29. The Managing Trustee shall once in every year, not later than the 30<sup>th</sup> day of September, place before the board the income and expenditure account for the year ending on the previous 3<sup>rd</sup> day of March and the balance sheet as on the date with the auditor's report or certificate thereof. The Managing Trustee shall give to the board such information and explanations as the board may require for proper understanding of the accounts and statements placed before it.
30. The Managing Trustee shall be the chief executive officer of the board and as such he / she shall have power and authority for and on behalf of the board.
01. To carry out the resolutions of the board
  02. To sign papers, receipts and accounts
  03. To pay money due by the trust and demand and get receipts there for the money so paid
  04. To demand and receive money due to the trust and issue receipts for the money so received
  05. To make draw, endorse, sign, negotiate or transfer cheques, promissory notes, bills of exchange, bills of lading, railway receipts, warrants and other negotiable or transferable instruments, Government securities or other securities.
  06. To lease out for a period not exceeding three years at a time, lands and properties of the trust which are ordinarily leased out.
  07. To initiate, prosecute, defend, compromise to arbitration or abandon legal proceedings or disputes and to sign all papers in connections there with.
  08. To appoint, employ, remunerate, remove, suspend, dismiss reemploy, replace, transfer and accept resignation of staff and workers permanently, temporarily or otherwise.

09. To call for the meeting or meetings of the board and
10. To execute all documents on behalf of the board.
31. No act of Managing Trustee requiring the previous sanctions of the board shall be invalid merely by the reason of the absence of such previous sanction, if the said act should subsequently be ratified by the board.
32. The quorum for a meeting of the board shall be more than ½ of total members.
33. The income and funds of the trust will solely be utilized towards the objects and no portion of it will be utilized for payment to the trustees / office bearers by way of profit / dividend / interest, etc..
34. In the event of votes being equally divided, The Managing Trustee shall have a casting vote in addition to his / her vote as a trustee of the board.
35. In all matters pertaining to the trust the decision of the majority of the trustees present at a meeting of the board shall be the decision of the board and shall be binding on all trustees of the board.
36. No act or resolution of the board shall be invalid by reason of there being one or more vacancies on the board. But no act or resolution of the board other than an act or resolution appointing or electing a trustee shall be valid if the strength of the board at any time of less ½ of the total strength.
37. It is hereby expressly declared that this trust is a public charitable trust and the trust hereby created is an 'irrevocable' one.
38. The trust will not function in the nature of conduction of a business activity and not for the purpose of profits and the trust will abide and satisfy the conditions stipulated in section 11(4) and proviso to section 80G (5) (i) of the Income Tax Act.

39. No act or proceedings of the board or of the Managing Trustee or of any trustees shall be deemed to be invalid by reason only if any defect in the appointment or the constitution of the board or on the ground that any member of the board was not entitled to hold or to continue in office by reason of any disqualification or by reason of such act having been done or proceedings taken during the period of any vacancy with office of the Managing Trustee or of any other trustees.
40. The trust shall conform to the provisions of the Indian Trust Act, 1882 in all matters not expressly provided for herein but in case any difficulty or doubt arising or any question in respect of the management or administration of the trust or any matter falling hereunder, the Managing Trustee shall on behalf of the board, apply to the court for opinion, advice, direction, or order and the trustees acting upon the direction if any the court shall be deemed, so far as regards the responsibility to have discharged their duties in respect thereof.
41. Any amendment to the trust deed will be carried out only with the prior approval of the Commissioner of Income Tax having jurisdiction on the trust and the Managing Trustee shall execute such amendments.

In the event of dissolution / winding up of the trust, the assets remaining as on the date of the dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another charitable trust whose objects are similar to those of this trust and which enjoys recognition under section 80G of the Income Tax Act.
